Whereas the TRUSTEES above named have decided to jointly set up a Trust for the Purposes and upon the terms and conditions more fully setout hereunder.

1. The TRUST SHALL be known as "EBENEZER MARCUS TRUST" (hereinafter referred to as TRUST).
2. The TRUST shall have its office at No.2, Lalbahadur St. Ram Nagar, Madras 53, and the books and all other documents belonging to the TRUST shall be kept in the safe custody in the said office.

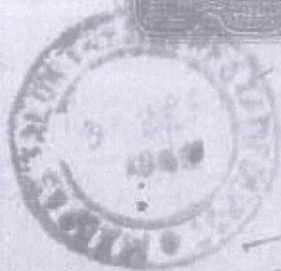

- e. Educate people through lectures, films, shows etc.
- f. To found form, set up a printing press to print, religious Magazines publications, and social books.
- g. To establish and maintain educational institutions for orphans, orphanages, such insitutions or orphanages shall not dicriminate in any way of the Basis of race caste or religion with respect of admission use of facilities.

6. The Trustees are empowered to:

- a. To permit the use of both the movable and immovable properties and assets of the trust insitutions.
- b. To acquire by lease, purchase gift, mortgage licence and beneficiary under any other trust or otherwise, bunds, properties mechnary act from government trusts corporations institutions societies as well as individuals.
- c. To sell, alineage, gift lease, mortgage or in any other legal manner, transfer the properties belonging to the trust to further

e. The Trustees shall be empowered to Co-Opt additional trustees to assist them in their work.

f. The Trustees do hereby appoint and nominate the following additional trustees by this Trust Deed.

- 1. Mr. J. Manmohan Marcus S/o. K.M. Jaganathan residing at No.F.182 Anna Nagar East Madras.
- 2. Mr. J. Kirubaharan Marcus S/o. K.M. Jaganathan residing at No.11, Rajaji St., Vinayakapuram Madras 53.
- 3. Mr. O.P. Sah S/o. Mr. T.L. Sah residing at No12, residing at V.V. Giri St., Ram Nagar, Madras 53.

g. The trustees may co-opt. such number of additional trustees as they may decide. The Trustees may select one amongst them (including the Co-opted trustees) to be the Chairman of the Board of Trustees. The Trustees may also select other office bearers like secretary, Treasures manager, correspondent.

h. The trustees shall be empowered to appoint and dismiss staffs connected with the trust.

7. All the amounts such as donations gifts etc. shall be

received in the name of the trust and only the trustees shall be empowered to receive the same for an on behalf of the trust. All

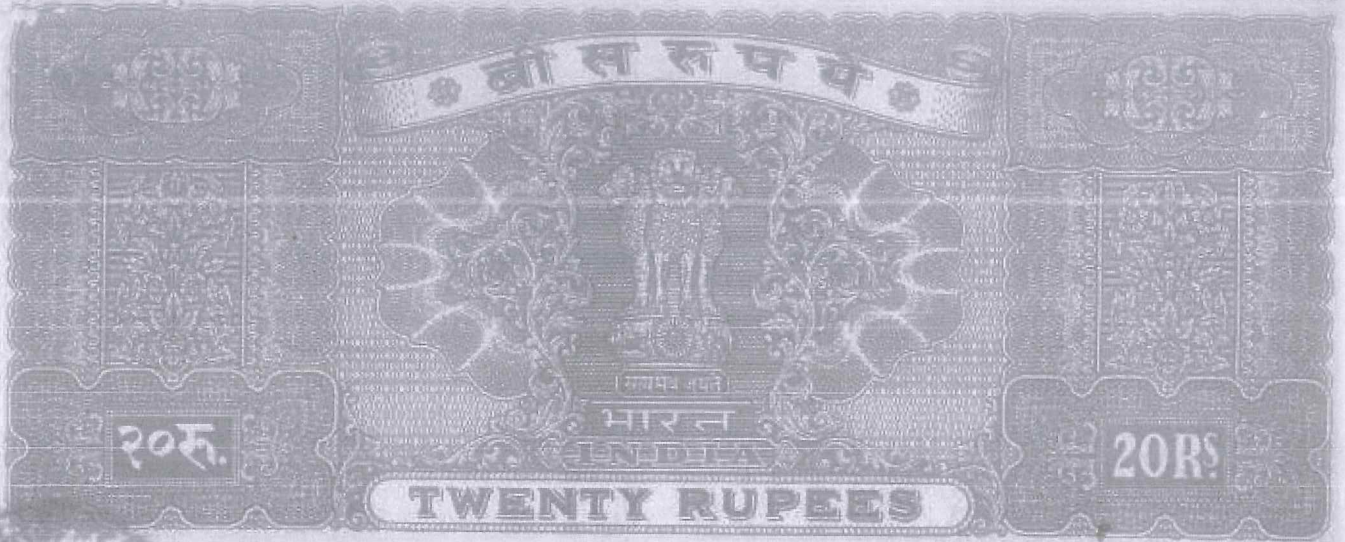

8. The Trustees shall be indemnified against any civil or criminal consequences in respect of any act that may be taken in any good faith.

9. There shall be maintained all accounts of the Trust institutions regularly. The accounts shall be audited by an Auditor before 31st March every year.

10. In the event of dissolution of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable trust whose objects are similar to those of this trust.
